PROVIDER: Enter the appropriate provider code in the column marked "REQUESTED". Each category and/or individual privilege listed must be coded. For procedures listed, line through and initial any criteria/applications that do not apply. Your signature is required at the end of Section I. Once approved, any revisions or corrections to this list of privileges will require you to submit a new DA Form 5440.

SUPERVISOR: Review each category and/or individual privilege coded by the provider and enter the appropriate approval code in the column marked "APPROVED". This serves as your recommendation to the commander who is the approval authority. Your overall recommendation and signature are required in Section II of this form.

SECTION I - CLINICAL PRIVILEGES

Category I. A physician who has completed the AMEDD 6A-F5 Course (Principles of Military Preventive Medicine), or who holds a Master of Public Health or equivalent degree. Category I providers serve as installation and unit preventive medicine officers (up to division level).

		Category I clinical privileges
		a. Provide consultation and develop policies for the control of diseases of public health and military operational importance including the use of vaccines, preventive drugs, and personal protection measures.
		b. Diagnose and treat outpatients with communicable diseases and subclinical infections of public health significance. Perform or supervise additional measures to interrupt disease transmission, including immunization, chemoprophylaxis, patient isolation, contact tracing, and behavioral counseling.
		c. Screen population groups for the presence of subclinical diseases using standardized health risk appraisals and non-invasive diagnostic tests.
		d. Provide medical consultations for unit deployments and individual travel, including assessment of geographically unique disease risks and ordering of appropriate interventions. Assist in the evaluation of illnesses acquired during international travel.
		e. Provide basic occupational medicine services to meet regulatory and force health protection requirements, including physical examinations, acute minor illness and injury care, and supervision of worksite evaluations and job-related medical surveillance.
		f. Maintain disease and injury surveillance systems, perform basic epidemiological investigations of public and military unique health problems and recommend corrective actions, as necessary. Notify local public health and Defense Medical Surveillance authorities of all diseases and injuries for which a report is required by statute or regulation.
		g. Provide preventive medicine services to units in the field during training exercises and deployments, including disease and non-battle injury surveillance.

Category II. Includes Category I. Requires completion of physician residency training or board certification in General Preventive Medicine and Public Health (GPM-PH). Certification in Occupational Medicine, or Aerospace Medicine, with advanced training or experience in epidemiology, communicable disease control, and public health management may be accepted in lieu of GPM-PH residency training or certification. Category II providers serve as Chiefs of Preventive Medicine Services and as preventive medicine staff officers at the corps level or above.

		Category II clinical privileges
		a. Maintain liaison with civilian public health (local, State, Federal) and military medical (installation, regional, higher command) authorities to ensure compliance with all regulations pertinent to preventive medicine, and to coordinate appropriate response to public health threats.
		b. Supervise technical personnel who provide environmental health services such as sanitary inspections, disease vector surveillance, assessment and monitoring of physical hazards, environmental sampling for detection of toxic substances, and health hazard review of new construction plans.
		c. Supervise the assessment of health needs in the community and the implementation of community-based interventions to modify or eliminate risks for disease or injury, and to promote wellness.

		d. Conduct targeted medical surveillance utilizing available health information systems, and design new systems to generate needed public health data. Perform epidemiological data analysis.
		e. Design and conduct epidemiological studies to address public health and force health protection problems, including the investigation of sentinel disease cases, clusters, outbreaks, and adverse changes in surveillance indicators. Analyze findings, formulate corrective actions, and provide appropriate risk communication.
		f. Apply scientific information to the development or updating of preventive medicine procedures, and to the formulation of health policy recommendations.
		g. Provide consultation to Category I providers.
		h. Serve as the local consultant on the public health aspects of nuclear, chemical, and biological weapons preparedness and response activities.*

*Granting of this privilege without supervision requires demonstrated completion of appropriate course(s) to obtain competency, e.g., official military courses in the medical aspects of unconventional weapons.
